**CHILD NOTES: Thirza Angelina HALE**

---

**Living (26 Mar 1887):** Thirza apparently gave a Bible to her son, Ormus B. Nay. Inside the cover of this Bible is an inscription from Thirza Angelina Marly to her son Ormus B. Nay.

**Death (aft 23 May 1892):** Thirza was still alive as late as 23 May 1892 when she wrote a letter pleading for the release of her son Ormus from prison. Family tradition is that Thirza is buried in Monroe, but there is not a legal record of Thirza's burial in Monroe, according to the sexton records there. It is suspected that she could be buried there in one of the graves that are occupied in the "Nay" plot, but not marked. (Out of 8 graves, 5 are marked, 3 unmarked, all occupied.)

**Burial:** It is uncertain where she is buried. A search has been done by many cousins, and the Monroe City Cemetery says there are plots that appeared to be filled, in the Nay Plot, but no record is on who occupies the plots. They are unmarked graves.

**Alt. Name:** Thirza apparently gave a Bible to her son, Ormus B. Nay. Inside the cover of this Bible is an inscription from Thirza Angelina Marly to her son Ormus B. Nay.

**General:** Copied from Family Group Record 15 Jul 1992.

Thirza Angelina Hale, the first wife of John Nay Jr., left John and children, when the latter part of her family was still young. She ran off with a soldier and was not heard from again. Because of Thirza's actions to her family, the Church excommunicated her from the records of the church.
