General: H rebaptized 16 Aug 1851. Divorced. Wife: Batch 8217302 Serial 42 gives DOB: 20 Mar 1843, An trin, Hillsborough, NH and Ordinance dates as shown.

Charles Wesley Warren and Laura Ann Nay obtained a temple divorce 1 Mar 1870 Laura Ann Nay was Baptized by Proxy 30 Apr 1901 SL Temple baptism record F Utah 56 book Q page 186 line 6693

Both Charles Wesley Warren and Laura Ann Nay were endowed by proxy 1 May 1901 and sealed on the same day. (Temple Index Bureau)

On the 18 of Sept. 1850, Charles, Amos S. and Mary Warren, and Wellington Wood, a lad of nine years, along with Sarah Grace and Her husband Daniel Wood, arrived on the future site of Springville. They had come with the Aaron Johnson company.

Burial (1940): The genealogy person at Cypress Lawn Memorial Park in Colma, California wrote the following: Laura A. Capron 44 years and John Saunders Capron 72 years are in our Laurel Hill Mound. Laurel Hill was a cemetery in San Francisco that was moved in 1940. The persons who were moved to Cypress Lawn are buried in underground vaults at Cypress Lawn in an area named "Laurel Hill Mound." There is a plaque there to the memory of all those buried there. Laura died June 16, 1887 in San Francisco.

General: 1880 Utah census has Laura Ann Capron living with oldest daughter and her family.

Marcus Warren said Laura Ann was born 20 Mar. 1843.

Laura's daughter Margaret Ann Warren Vessing and Loretta C. White Cahn, Bert E. White and Louis M. Cahn are buried at Cypress Lawn Memorial Park in Colma, Ca. in Section S Tier 5 Niche 37. Margaret's dates are b. March 18, 1864 d. Jan 20, 1948. Loretta C. White Cahn b. Nov. 16, 1886 d. Sept. 22, 1970. Bert El White b. Nov. 21, 1884 d. Aug. 27, 1942. Louis M. Cahn b. Sept 29, 1882 d. March 2, 1972.

Death (10 May 1942): Cause of death: arteriosclerosis generalized.

General: Baptism date from Logan Temple Records (#5900, Book A, p.164) differs from others sources Sep 1870. Alonzo Zenos Warren and Frances Ellen Standley his wife were re-baptized 6 Oct. 1887 by John Henry Hays and re-confirmed the same day by George D. Snell.

CHILD NOTES: Margaret Ann WARREN

Death (20 Jan 1948): Died of Bronchiopneumonia due to generalized arteriosclerosis. Cerebral arteriosclerosis, senility.

Burial: Buried Colina, Calif. San Jose.

CHILD NOTES: Harriet Matilda WARREN

Death (27 Nov 1940): Died of chronic myocardites due to arteriosclerosis.
